#### **BOARD NOTES**

At the February 15<sup>th</sup> Board Meeting, the Board approved the following:

- + U.S. Fitness to move the exercise equipment so the new carpet can be laid.
- + Purchase four new toilets from Faucet Direct.
- + Purchase two new office desks from Office Depot/Office Max.
- + Groot Industries to deliver a 30 yard dumpster for the renovation project.
- + SMS to remove the platform in the Exercise Room.
- + Best Buy Carpets to install quarter round at the front entry and bathrooms.
- + Best Buy Carpets to move the furniture for the new flooring project.
- + SPMS to acid clean the indoor pool/spa.
- + SPMS to replace the spa circulating pump motor.
- + SPMS to install a new chlorine/PH controller for the indoor pool.

#### INDOOR POOL/SPA CLOSING

Because of the Renovation Project, the Indoor Pool and Spa will be closed from Thursday, March 1<sup>st</sup> through Friday, March 23<sup>rd</sup>. The interior of the Clubhouse will be painted, including the Indoor Pool room. The work will require scaffolding, which would be dangerous for anyone walking in the Clubhouse.

During this closing, the Indoor Pool and Spa will be drained and acid cleaned. This is our Annual Cleaning.
